Governor's School for the Arts

Purpose, Philosophy, and Goals

The Tennessee Governor's School for the Arts (GSFTA) is a summer residential program for rising 11th- and 12th-grade students in Tennessee. Administered by the State Department of Education and hosted at Middle Tennessee State University, the program offers intensive study programs in art, dance, filmmaking, music, and theatre. Students are selected in competitive auditions and portfolio reviews during the months of January and February. Auditions are open to Tennessee residents who attend public, private, or home schools.

The Governor's School for the Arts at MTSU focuses on music, filmmaking, dance, visual arts, and theatre. In music, students rehearse daily in major ensembles such as orchestra, band, or chorus. Chamber ensembles and private instruction are available for strings, brass, woodwind, percussion, piano, and voice. Dance students concentrate on classes in classical ballet and modern dance with experiences in several other styles. Visual Art studies may include painting, ceramics, drawing, graphic design, photography, printmaking, and sculpture. Theatre students explore all facets of the theatrical arts to create original theatre together. Performance students participate in acting, musical theatre, stage movement and combat, while Design/Tech students study scenic, lighting, costume, and sound design. Filmmaking students experience narrative filmmaking from concept to completion, and will learn each position on set and editing/post-production techniques while creating their own short film.

Each day, students attend classes for which they receive 3 hours of college credit. Students work in labs and studios and participate in rehearsals. While most of their time and energies are spent in their chosen arts areas, they also have opportunities to learn about other art forms. Throughout the 3 weeks, students participate in school-wide assemblies that include exhibits, lectures, and performances by outstanding professional artists.

Students who attend the GSFTA arrive with skills and abilities they have learned from working with dedicated public and private teachers in their hometown schools and studios. GSFTA faculty strive to build on those skills and abilities. The program includes an exciting and intensive focus on the arts, and students have the opportunity to enhance their talents, increase their understanding of their art forms, and develop valuable perspectives about the contributions of all of the arts to the quality of life. It is hoped that after the GSFTA experience, students will return to their hometowns with renewed commitment to the arts and with fresh ideas and new perspectives. When students share their experiences and ideas with their families and friends, the GSFTA will have accomplished its mission to reach across the entire state and enrich all of Tennessee's public and private schools and all its many communities.

General Information

1. Upon arriving at the dormitories after registration, you will be issued your room key and a swipe card to access your dorm hallway.
2. After Parent/Student Orientation, students will be restricted to campus. At no time are students allowed to leave the MTSU campus without advance permission of the assistant dean of students or the GSFTA director. All stores and businesses bordering campus are considered off-campus.
3. **Visitors.** Due to the intense study schedule of GSFTA, there is insufficient time to entertain visitors. Therefore, parents/guardians, other relatives, and friends of students are not allowed to visit during the school session.

All special needs or issues should be directed to the GSFTA Deans of Students through Remind.

It is important for students to know that boyfriends or girlfriends are not allowed to come and date during GSFTA.

4. **Overnight.** Students are not allowed to go off campus to spend the night during GSFTA. Students are not excused to visit relatives, participate in family vacations, attend family reunions or family ceremonies, and so forth. Please do not ask for exceptions. In the case of an emergency, please communicate through Remind.
5. **Identification cards.** All GSFTA students and personnel must wear their GSFTA ID Badges at all times. These ID cards not only identify students as GSFTA personnel and authorize their presence on campus, but also allow admittance to all special events, the dining hall, and the dorm halls. For security purposes, persons without proper identification will be subject to questioning by campus police. Report lost ID cards immediately to the GSFTA office (Jones Hall 130). The charge for lost ID cards is \$10 for each replacement.
6. **Bulletin board/Remind App.** Scheduled activities, announcements, messages, and changes in the schedule will be posted for each arts area in their primary class buildings. Counselors and Deans of Students also use the Remind App to communicate with students. Students are responsible for staying informed by keeping up with posted material. Ignorance of changes will not constitute an excuse.

7. **Dress Code:** GSFTA students should dress appropriately at all times, whether as prescribed by the specific arts area during class time, or as detailed below. Shoes must be worn during the day unless specifically instructed otherwise during class.

Students may wear:

- Clothing that allows for personal expression while covering areas required for a learning environment.
- Tops with straps of any width, including tank tops and off-the-shoulder styles, as long as they fully cover the chest and torso.
- Bottoms of any style (pants, skirts, shorts, leggings, dresses, etc.) that provide appropriate coverage in all movement.
- Religious, cultural, or medical head coverings.
- Clothing with positive messages, artistic expression, or social statements, as long as they are not hateful or discriminatory.

Students may not wear:

- Clothing or accessories that feature hate speech, violence, profanity, pornography, or discriminatory messages.
- Items that promote the use of illegal substances or activities.
- Clothing that exposes undergarments (except for straps that may be visible).
- Accessories that could be considered a weapon or pose a safety hazard.

Students will receive one Governor's School t-shirt at orientation.

It is recommended that you bring a laundry marker with you to label your t-shirts with your name on the tag inside the collar.

Music Finale Attire:

Concert Black for all Music Students- Options Include:

- 1) Black floor length dress with shoulders covered (if not floor length, black opaque tights or leggings may be worn), black closed toe dress shoes
- 2) Black dress pants or black floor length skirt (if not floor length, black opaque tights or leggings may be worn), solid black button down shirt or solid black blouse with shoulders covered, black closed toe dress shoes, black dress socks or black opaque tights

Please make sure the attire is BLACK not gray/navy

DANCE students: Please refer to the information shared by the Dance Chair for details regarding required dance class attire and performance needs.

8. **Attendance.** Students are required to attend all classes, rehearsals, and day and evening performances. Each student must accept personal responsibility for rising early enough in the morning to be on time for early classes. GSFTA has a rigorous and demanding schedule. Unexcused absences are not permitted.
9. **Transportation.** Students are required to use the buses provided by the school for all scheduled trips. No other means of transportation may be used.
10. **Vehicles.** If students bring vehicles to the GSFTA, they must turn in the keys at registration. Students are not permitted to operate any vehicles during the school session. Students who leave their vehicles parked on campus must obtain a parking permit from the GSFTA office on registration day. Vehicles without proper parking permits will be towed.
11. **Drugs.** Alcoholic beverages and illegal substances are strictly forbidden.
12. **No smoking.** Smoking or vaping is prohibited at the Governor's School for the Arts.
13. **Incidentals.** Students will not need any money for lodging and meals at the GSFTA but should bring money for snacks and personal items. There are ATM machines in the Student Union Building. Parents may also set up a **Raider Fund** Account that is linked to the student's MTSU ID, and students can spend those funds on campus. For more information:

There will be extracurricular activities for students. Students may wish to bring money to make purchases at off-campus events.
14. **Instruments.** Music students must bring their own instruments. Musical instruments should be in very good condition. If maintenance or repairs are needed, GSFTA cannot pay for them. Percussionists should bring sticks, mallets, and any other implements they may need for playing percussion. Double-reed students must bring several extra reeds. At registration, music students will be assigned lockers for storing their instruments. Each student must bring a **combination lock** for securing his or her instrument in the locker. Although GSFTA does pre-assign everything it can to promote the security of equipment, the school and the State of Tennessee do not carry insurance to cover loss, theft, or damage to equipment, including musical instruments. Students should check their family's homeowner's insurance to see if their instruments will be covered while they are at GSFTA. If they are not, students are encouraged to purchase insurance coverage before arriving at the school.
15. **Student photographs** are taken with each arts area, and the photos will be available for purchase at gsfta.com.
16. **Bicycles.** Bicycles may be brought to campus. They must be parked in bicycle racks and may never be brought into buildings. Students must bring chains and locks for securing their bicycles. GSFTA is not liable for and cannot replace lost or stolen equipment.
17. **Cell Phones/Computers/Personal Property:** Cell phones may be

brought to the school but must not be used during class, rehearsals, or performances. It is suggested that computers be left in rooms during class/performance times.

The school is not responsible for the loss of any cell phones or computers or any other personal property. Keep all valuables locked in your room.

Cyber Respect

1. Aggressive behavior among students admitted to GSFTA will not be tolerated. Action such as making threats, spreading rumors, and/or attacking someone physically or verbally via electronic technology will result in immediate disciplinary action.
2. Electronic technology includes devices and equipment such as cell phones, computers, and tablets, as well as communication tools including social media sites, text messages, chat, and websites.

Examples of disrespect include mean text messages or emails, rumors sent by email or posted on social networking sites, and embarrassing pictures, videos, websites, or fake profiles.

Disciplinary Code

Students are expected to follow the rules and regulations set forth by the Governor's School for the Arts so that all participants may enjoy the full benefit and opportunities provided by this program. GSFTA students are expected to exhibit a high level of maturity. It is with this, as well as the students' personal safety in mind, that these rules have been established and must be followed without exception.

The following are unacceptable acts and will result in disciplinary action:

1. The use or possession of alcoholic beverages or illegal drugs.
2. Leaving the dormitory after lights out.
3. Misuse/vandalism of MTSU or GSFTA property.
4. Leaving campus without permission, which includes leaving campus with parents or guardians.
5. Riding in any car without proper authorization including after performances or outside events.
6. Unexcused absences/tardiness from scheduled classes, school programs, or events.
7. Fraternizing with college students or persons other than GSFTA personnel.
8. Failure to be in one's assigned room at the 10:30 p.m. dorm check.
9. Failure to properly display name badge.
10. Failure to complete classroom assignments and projects on time.
11. Physical abuse of any person or conduct that threatens or endangers the health of any person.

12. Failure to cooperate with University or GSFTA faculty, staff, counselors, or other appropriate officials.
13. Flagrant and intentional disrespect for or mistreatment of faculty, staff, counselors, or other students.
14. Tampering with emergency equipment, locks, fire alarms, fire hoses, fire extinguishers, and so forth.
15. Willful disruption of programs, rehearsals, and performances.
16. Writing on sidewalks or buildings with chalk, or by any other means, is strictly forbidden by University policy and is considered vandalism.
17. Smoking, vaping, or the use of smokeless tobacco.
18. Use of a cell phone in class, rehearsals, or performances.
19. Incense, diffusers, or plug-ins of any kind.
20. Academic Misconduct—Students must abide by MTSU's policies regarding plagiarism and cheating. Projects and assignments must be the student's own work and may not use unauthorized use of AI software. Additional details here: <https://faculty.mtsu.edu/academic-integrity/>

Note: These rules have been provided as general guidelines. Any misconduct or behavior deemed inappropriate will be dealt with on an individual basis.

Disciplinary Procedures

Disciplinary reports will be submitted to the Deans of Students, who will take the appropriate action. Upon a third report, students will be referred to the Director, placed on disciplinary probation, and face expulsion from the school if the behavior persists. Parents will be notified of probation status. A student may be expelled without disciplinary probation and without notification of parent or guardian for either a single incident (such as the use or possession of a controlled substance or damage to emergency devices) or for a pattern of misbehavior deemed as sufficient grounds for expulsion by the Director.

Refund Policy

1. A full 100% refund of fees will be provided to students who withdraw on or before June 7, 2025.
2. Students who withdraw after June 7th will receive a 50% refund until June 14th.
3. No refunds will be given after June 14, 2025.
4. No refund of fees will be made to students who are dismissed from the school.

Dormitory Information

1. The Governor's School uses a traditional college dorm living arrangement. Coed visitation is not permitted. All students must be in their assigned rooms each night at dorm check. It is extremely important that students accept the responsibility never to leave the dorms at night after room check, except in

case of an emergency. Students and parents should talk about this important rule at the beginning of school. **Also, students and parents should remember that they have signed an agreement to adhere to all Governor's School rules and regulations.**

2. **Visitation.** Coeducational visitation is not permitted at any time in dormitory rooms. No outside visitors are allowed in dormitory halls, or outside of performances or special event locations.
3. **Safety.** Students will only gain access to dormitory halls with their MTSU issued I.D. swipe cards. **Only GSFTA students** are allowed in the dormitories, with the exception of move-in/move-out days. Students are not allowed to grant access to anyone outside of GSFTA. The replacement of a Swipe Card will be \$30.00.

NO exterior and interior doors can be propped open at any time per MTSU Policy.

4. **Locks.** Students must lock their dormitory rooms whenever they leave. They should never leave room keys in classrooms or the dining hall. Students must return their keys at the dorm check-out desk at the close of the school. If a key is lost, it must be reported to a counselor immediately. **There is a \$94.93 replacement charge. Students who do not return their keys at check-out will be charged \$94.93.** If there are problems with any door locks, please alert the front desk staff.
5. **Roommates.** At registration, you will be assigned a room in the dormitory. You will also be assigned a roommate. Part of the Governor's School experience is developing new friendships, new perspectives, and new ideas. For this reason, students from the same city or community are not assigned to room together. **Roommate requests from students are NOT accepted.** Students may change rooms only under extreme circumstances and only with the approval of the Dean of Students.
6. **Linens.** Linens are **not** furnished by the GSFTA. Students must provide their own pillows, pillowcases, XL twin-size sheets, towels, and washcloths. Students must provide their own personal effects such as toilet articles, laundry soap, shower soap, blankets, casual clothing, warm sweaters or jackets, raincoats, umbrellas, bathing suits, and alarm clocks. Be sure to bring a blanket. If you have further questions regarding dorms, please call MTSU Housing at 615-898-5396.
7. **Trash.** There are no trash receptacles in the individual rooms. Students should bring a small trash can and trash bags. **Students must dispose of trash in the dumpsters outside the dorms.**
8. **Counselors.** Counselors support the GSFTA student experience by assisting in arts area classes, helping maintain order, aiding in room check on a nightly basis, and checking daily to see that each room is locked. There will be two counselors assigned to check each room. They are to assist students with any problems or concerns. While counselors will be kind and considerate to students, they must see that all school policies and

rules are observed. Students are expected to cooperate fully with the counselors and to treat them also with kindness and consideration.

9. **Television.** Televisions are located in the lobby of each dormitory. There are no TVs provided in the dorm rooms.
10. **Telephones.** Telephones are not provided in dorms. Students are encouraged to bring phones.

If necessary, students may make **emergency** phone calls without charge at the GSFTA office in Jones Hall 130.
11. **Personal property.** Respect for the personal property of others is expected. However, the responsibility for personal property lies with the individual and not the school. Students should put their names on all personal belongings, luggage, and musical instruments.
12. **Air conditioning.** Windows in the air-conditioned dorms should never be opened. Please report any issues to the front desk staff.
13. **Dorm check.** All students are to be in their assigned rooms for dorm check at 10:30 p.m. each night unless otherwise indicated on the schedule. Lights out will be at 11 p.m. Quiet hours are between 11 p.m. and 6:30 a.m.
14. **Fire regulation.** The **burning of candles, incense, etc., is prohibited.** No incense of any kind is to be brought onto campus. Cooking in the dormitory rooms is not allowed. The use of hot plates, electric skillets, etc., is prohibited. There will be fire and tornado drills during the school. Everyone is required to follow instructions during drills. Procedures will be discussed at hall meetings.
15. **Microwaves/Refrigerators.** Microwaves less than 750 watts and refrigerators of 3.7 cubic feet or less are allowed.
16. **Takeout Food.** Food may be ordered from off campus and delivered to dorm lobbies. Food needs to be ordered so that it arrives no later than 10 p.m. Place trash in outside receptacles. **DO NOT LEAVE TRASH IN LOBBY.**
17. **Hall meetings.** The counseling staff will schedule hall meetings as necessary. Full dormitory meetings may be scheduled by the Deans of Students. Attendance is required for both.
18. **Radios/audio.** Radios (or other music/audio) may not be played after lights out.
19. **Safety regulations.** Safety regulations prohibit running in the dormitories and climbing trees, buildings, structures, etc.
20. **Musical instruments.** Musical instruments may not be played in the dormitories at any time unless in a specified practice room.
21. **Room checks.** Rooms will be frequently checked by counselors. Students should make reasonable efforts to keep their rooms in good order. Trash cans should be emptied. Clothes should be on hangers. **Absolutely no open food and drink containers should be left in the room.**
22. **Unauthorized personnel.** Students should always report to counselors immediately the presence of anyone other than MTSU personnel and GSFTA personnel in the dormitory halls.

23. **Maintenance.** Maintenance problems with air conditioning, lights, plumbing, and so forth should be reported to counselors.
24. **Alcohol and drugs.** Alcoholic beverages are illegal on campus. GSFTA is unconditionally opposed to and intolerant of the use of illegal and/or controlled substances. Students found in possession of illegal drugs or alcohol will not be permitted to remain in the GSFTA program. MTSU is a tobacco free campus, and cigarettes and vaping will not be permitted at any time.
25. **Damages.** GSFTA is a summer guest at MTSU. All members of the school must be careful not to mistreat University property. **Any damages to dorm rooms, classrooms, the cafeteria, or other University property will be charged directly to those who caused the damage. Students and/or their parents/guardians will be responsible for damages students cause.**
26. **Inspection.** All dorm rooms are the property of the University. While students' rights to privacy will be honored as much as possible, GSFTA officials have the right and the obligation to inspect any room if there is reason to believe that it may contain alcohol, illegal drugs, or tobacco products.
27. **Security.** MTSU Campus Police patrols the campus 24 hours a day. If any emergency occurs, the MTSU Campus Police will be contacted.

Bookstore

Phillips Bookstore is located in the Student Union Building. The bookstore stocks food items, paper goods, nonprescription medicines, school supplies, etc.

Clinic/Health Services

MTSU Health Services is located in the Health, Wellness, and Recreation Center (615-898-2988) and has been secured for use by the GSFTA students and staff. Students who need medical care should report to a counselor. Students are welcome the use of MTSU Health Services but must be accompanied by a counselor. Any fees incurred for tests or x-rays must be paid at time of treatment.

Students who need medical attention other than that available at Health Services, or upon request, may be taken to the hospital or a local physician. Prescription drugs may be obtained at the MTSU or a local pharmacy. Students should check with their counselors for procedures. The school is not responsible for any medical expenses of students.

A note about student illness: It is MTSU Housing policy that students can not isolate in the dorm rooms. Should a student test positive an illness that requires isolating from their roommate, the student will need to quarantine off-campus.

Computer Technology Access

Faculty, staff, and students at Middle Tennessee State University have access to

computers and the internet through campus computer labs and the Walker Library. All users are expected to maintain the highest standards in the use of computer technology and to respect the academic values held by a scholarly community whose purpose is to use all facilities in the pursuit of educational and public service goals. However, library personnel do not monitor or censor the use of University computers. If it is discovered that a student has failed to maintain appropriate standards, the student may be dismissed from the school.

Dining Facility

One of the University's dining facilities is assigned for use by GSFTA. Students must have their name tags prominently displayed for admittance. The GSFTA dining hall is unable to provide free meals for family members or guests. If you have specific dietary questions, please contact Ed Gilbert at 615-898-2842

Laundry

Coin-operated washers and dryers are located in dormitories. Students must use the facilities in their dorms and may not go to other dorms. Students should never leave clothes unattended in the laundry rooms (\$1.50 per load in washers - \$1.50 per 45-minute drying cycle).

Library

The James E. Walker Library contains over 1 million volumes and more than 33,000 serial specials. It also has computer labs and printers. The Howard Music Collection is in the reference area on the first floor of the Walker Library. **GSFTA students** may examine scores and use reference works **in the library only**. Materials may not be checked out.

Mail

All mail will be delivered to the students each evening at their dorms.

Do not send cash through the mail! If you need to send money to students, please send traveler's checks or money orders. These may be cashed at the University Bookstore. MTSU nor the Governor's School will be responsible for cash sent through the mail.

Places of Worship

Ensemble participation and studio work in all of the arts is required throughout the GSFTA sessions including Fridays, Saturdays, and Sundays. However, students may attend worship services on weekends when those services do not conflict with GSFTA events. Students who would like to attend services must have written approval from their parents or guardians (see rules agreement in student packet). The Governor's School cannot provide transportation. **Students may not return home or leave the Murfreesboro/Rutherford County area to attend services.** If attending worship services, students must arrive back to the MTSU campus by 2 p.m. or earlier depending on discipline schedule.

Recreation

Swimming Pool and Recreation Center

When time permits, students have access to the MTSU Rec Center. In addition to workout facilities, there are both indoor and outdoor pools and a sun deck at the Recreation Center. Students must present their ID cards for admittance.

Students who want to exercise (walk or run) around the campus outside of the Rec Center will discuss the timing and location with their counselor.

Testing

Students are not excused from GSFTA for student testing (ACT/SAT) even if those tests are administered on the MTSU Campus. Please schedule those outside of June 7-29, 2025..

Parents Visiting Evening Performances

During the school, several concerts/performances will be open to the general public. We welcome parents to attend, but for safety purposes, we ask that parents do not visit the dorms or drive their children to or from the dorms before or after these performances. It is impossible for school staff to recognize all the parents, and students seen talking, walking, or riding with someone other than

school personnel is cause for alarm. Parents who live in the middle Tennessee area can easily attend more events than those who live in other areas of the state. This causes some students to feel homesick when other parents visit their children, and they can't enjoy the same privilege. We ask that you keep these two things in mind when attending performances.

If you need to bring items to the school for your child, we ask that you do this during daytime hours and leave them at the GSFTA office, not at the dorms.

Thank you for your understanding and help. The safety and well-being of each student is our top priority.

Finale Events

All finale events and performances will be held on campus June 27-28, 2025. Specific times for area performances and exhibits will be available at registration on June 7, 2025.

Check-Out

June 29, 2025

It is important that our students experience each other's final presentations of their work at GSFTA, so the entire student body must attend the finale performances. Students will check out on June 29, 2025. Student check-out will begin at 8 a.m. and end at 1 p.m. Additional information will be available on registration day.

Procedure

- After you have packed and cleaned your room, inform your counselor.
- The counselor will issue you a check-out slip. Take this along with your key to the MTSU Residential Staff located in the lobby.
- The Residential Staff will sign you out. Turn in your room key at the dorm desk.
- Remember: There is an \$94.93 charge for lost keys. Be prepared to pay for lost at check-out if you cannot turn in your key.
- Any damage to the room will be assessed immediately following check-out. Students are responsible for any charges resulting from damages.
- There will be charges for any garbage left in the lobby, dorm rooms, or bathrooms. TAKE GARBAGE TO OUTSIDE WASTE RECEPTACLES.
